**SPECIFICATION FOR FENCING OF THE FRONT PORTION OF THE
LANDFILL SITE.**

1. Area to be fenced is = 200M Long.
2. Double galvanized gate, each side of the gate is 4m long.
3. Galvanized steel poles = 24 poles and each pole = 3m high.
4. 8 rolls of plain wire.
5. Type of a fence to be used must be a galvanized security fence **diamond dash wire** shape 3m high.
6. Each side of the area to be fenced = 100 m long
7. 10x bags cement for concrete work.
8. 4x thick galvanized steel poles for corners and height = 4 each pole.
9. All the steel poles must be erected in the ground by means of concrete.
