- Submit CV and 3 reference letters with contactable references to prove previous relevant experience in the review of GRAP financial statements.

- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
