INTRODUCTION

Port St Johns Local Municipality hereby invites detailed proposals from suitably qualified service providers for the provision, implementation, training, support and licensing of a software solution capable of generating MFMA-compliant Budget and In-Year Reporting schedules.

SCOPE OF WORK

The appointed service provider must supply a software solution for local government capable of:

- Generating National Treasury Schedules A, B, C, D, E and F
- Supporting applicable mSCOA versions
- Producing MFMA Section 52 and Section 72 reports
- Generating MFMA Circular 93 compliant PDF schedules.

Functional requirements

The solution must provide, as a minimum:

- Ability to utilise text data string files uploaded to National Treasury as a data source
- A single source of truth, ensuring consistency between data strings and populated schedules
- Automatic alignment of data strings to National Treasury validation and alignment rules
- Generation of MFMA Circular 93 compliant PDF schedules
- Schedule reconciliations demonstrating alignment between data strings and reports
- Support for MFMA Section 52 and Section 72 reporting
- Ability to extract schedules and screenshots for Council and oversight reporting



Technical requirements

- Desktop-based application
- Ability to operate independently using data strings
- Full integration with any Municipal Financial Management System (FMS)
- Where integration is required, development must be done at no additional cost to the Municipality

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.
- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
